TERMS AND CONDITIONS | SEASON PASS

- Upfront payments only, being made by cash, EFTPOS or credit card
- Children under the age of 2 years are entitled to free entry
- School children up to and including the age of 16 years are considered eligible to purchase a child season ticket. Applicants under 18 years old must get a parent/guardian to sign the agreement and supervision requirements must be adhered to at all times
- Passes must be produced upon entry. Casual rates will need to be paid for failure to produce a valid pass. If requested appropriate photo identification must be shown on entry to Mid-Western Regional Council swimming pools
- Persons to be included on a Family Season pass, or Pensioner Family season pass, must be members of the immediate family only (i.e. Parents and children) The only exception to this is Wards of the State under guardianship
- To be entitled to purchase a pensioner season pass the applicant must be a holder of a Pension Card issued
 by the Department of Human Services or the Department of Veteran Affairs. This card must be produced for
 verification before issue of the ticket. Unemployed persons who are not holders of a Pension Card are not
 eligible to purchase a Pensioner season pass
- Only parents that are holders of the for Pension Card issued by the Department of Human Services or the Department of Veteran Affairs are eligible to apply for a Pensioner Family season pass
- Key Tags are non-transferable. Lost Key Tags requiring a replacement will incur a fee of \$5
- All users are required to comply with the Centres conditions of entry. A copy may be provided upon request and the conditions are displayed in the reception area of the swimming complex
- Children under the age of 10 must be closely supervised by an adult (16 years and over). Entry is subject
 to Royal Life Saving Keep Watch Program supervision responsibilities. This policy can be provided upon
 request and signs displayed around the swimming facility
- Failure to comply with the conditions of entry and all reasonable requests made by pool staff may result in expulsion from the Centre and season pass cancelled
- Refunds are considered and processed by management only when they have been submitted with an attached medical certificate or letter outlining the extenuating circumstances
- A season pass gives you unlimited use of local swimming centres throughout the pool season as advertised
 on Councils website. Opening times and lane availability are subject to change at short notice and refunds
 will not be issued in this instance. This includes full closure for swimming events, health and safety
 requirements and inclement weather
- Terms and conditions are subject to change at any time subject to discretion. In this instance customers will be notified
- The holder of Senior Card is eligible for a fees at Pensioner pricing
