## CONDITIONS OF HIRING HORSE STABLES

- Booking to be submitted online and confirmed by Mid-Western Regional Council before 1. horses are stabled. Phone (02) 6378 2850.
- 2. Mid-Western Regional Council must have an up to date contact number of the hirer at all times.
- 3. Stables and open yards are to be cleaned daily and manure placed in the allotted area, near the sand roll, not left in front or behind stable/open yard. If the sand roll is used it must be cleaned and raked immediately. At no time is the hirer to utilise vacant stables for storage of tack/feed or personal effects.
- Payment of stable and yard rental fees are to be at least 30 days in advance or at the time 4. of booking online or in person at Mid-Western Regional Council. Failure to comply with this condition will result in immediate eviction from the Showground.
- 5. The hirer is to be responsible for keeping stable frontage and open yard clean and clear of rubbish, i.e. food packaging, bottles, plastic bags, buckets and any gear etc. All articles left lying around will be confiscated and must be retrieved from Mid-Western Regional Council if needed.
- 6. During major events such as (but not limited to) the Mudgee Show, the hirer may be asked release their day yard to the event coordinator.
- Mid-Western Regional Council will not accept responsibility for any loss or damage to hirer's 7. property.
- The Madeira Road gate is to be kept closed at all times. 8.
- 9. Horses are NOT to be let loose on the Showground and tethered horses must be supervised at ALL times. Unattended horses may be impounded, with costs to be paid by the horse owner.
- Dogs are to be kept on leads and secured at all times. 10.
- 11. Horses are to be disease free upon stabling
- Any damage caused by negligence or accident must be reported to the caretaker within 24 12. hours

- If horses need urgent attention and the owner is unable to be contacted, the Mid-Western Regional Council will call a Veterinarian to attend at the HORSE OWNER'S expense.
- 14. The hirer shall indemnify and hold harmless the Mid-Western Regional Council from any claims actions suits or demands arising from the activities undertaken at the Showground by the hirer its agents servants or employees.
- 15. The hirer shall hold a Public Liability Insurance Policy for the maximum amount possible (at least 10 million). The policy shall be extended to indemnify the Mid-Western Regional Council and the Showground Management Committee against all claims which may arise from the hirer's occupation of the showground
- 16. No hirer shall interfere with other horses or property.
- 17. One horse only is to be housed in a stable at any given time (with the exception of being with foal).
