REPORT BY THE MANAGER - INFRASTRUCTURE PLANNING

RECOMMENDATION

That Council:

- 1. receive the report by the Manager Infrastructure Planning on the Acceptance of Road Safety Program, School Zone Infrastructure Sub Program Round 2 Offer Funding;
- 2. accept a total of \$196,000 in grant funding from the Federal and State Government's Stimulus Commitment Road Safety Program, School Zone Infrastructure Program Round 2 for pedestrial refuge, kerb extension and/or linemarking works in six school zones across Mid-Western Region LGA;
- amend the 2021/22 Budget to allocate \$180,000 to upgrade school zone infrastructure at Mudgee Public School zebra crossing at Perry Street to be funded from grant funding;
- 4. amend the 2021/22 Budget to allocate \$16,000 to repaint existing linemarking in school zones at Kandos Public School, Rylstone Public School, Ilford Public Schoo, Lue Public School and Ulan Public School to be funded from grant funding; and
- 5. authorise the General Manager to finalise and sign the funding agreement with Transport for NSW.

Executive summary

Council received in October 2021 the funding offer for Round 2 of the School Zone Infrastructure Sub- Program to deliver improvements to school zones in six locations for a sum total of \$196,000.

The program works are fully grant funded.

The purpose of this report is to authorise the General Manager to accept funding and sign the funding agreement and any other relevant documentation as required to allow the delivery of the prescribed school zone upgrade works.

Detailed report

The School Zone Infrastructure sub-program is part of the \$540 million Federal Stimulus NSW Road Safety Program, which was announced on 4 March 2021. Council received in October 2021 the offer of funding under Round 2 of the School Zone Infrastructure Sub- Program. Under this offer the following improvement works are required to be completed in this financial year period.

Rylstone Public School – repainting of school zone linemarking	Repainting of existing Dragon's Teeth linemarking and school zone 40km/hr patches on Mudgee and Dabee Sts, at Rylstone Public School.	\$3,000
Ilford Public School – repainting of school zone linemarking	Repainting of existing Dragon's Teeth linemarking and school zone 40km/hr patches on Castlereagh Highway, at Ilford Public School.	\$2,000
Lue Public School – repainting of school zone linemarking	Repainting of existing Dragon's Teeth linemarking and school zone 40km/hr patches on Swanston St and Lue Rd, at Lue Public School.	\$2,000
Ulan Public School – repainting of school zone linemarking	Repainting of existing Dragon's Teeth linemarking and school zone 40km/hr patches on Main St, at Ulan Public School.	\$3,000
