8.7 2021-22 Local Heritage Grant Allocation

RECOMMENDATION

That Council:

- 1. receive the report by the Manager, Strategic Planning on the 2021-22 Local Heritage Grant Allocation; and
- 2. provide a Local Heritage Grant to the following projects:
 - a) \$2,000 for roof restoration at 29 Belmore Street, Gulgong;
 - b) \$2,000 for fence replacement at 73 Belmore Street, Gulgong;
 - c) \$2,000 for external painting at 2 Canadian Street, Gulgong;
 - d) \$2,000 for restoration works and external painting at 101-103 Herbert Street, Gulgong;
 - e) \$3,000 for verandah restoration at 104-106 Mayne Street, Gulgong.

Executive summary

NSW Councils enter into the Local Heritage Grants program with The Heritage Division of the NSW Department of Premier and Cabinet. This year's total budget for local heritage grants is \$11,000. Nine applications were received and 5 are recommended for funding.

Council's Local Heritage Grants Policy provides criteria and funding priorities for consideration in the allocation of the grant funding.

This report details a recommended allocation of the 2021-22 Local Heritage Grants.

Disclosure of Interest

Detailed report

Applications for funding under the Local Heritage Grants Program closed in October 2021. Nine applications were received. Two of the applications failed to provide the required information.

An application was received from the owners of 81 Mayne Street, Gulgong. Although the dwelling is located within the Gulgong Heritage Conservation Area, it is not an individually listed item. Due to the number of heritage listed properties applying for grants and taking priority, funding is not recommended this round.

Council's Local Heritage Grants Policy states funding will only be provided to a property every five years. St Stephen's Church Bylong received funding within the last five years, accordingly it does not meet the criteria for a grant this round.

The applications have been summarised in the table provided as Attachment 1.

Council's Local Heritage Grants Policy identifies the following funding priorities:

- Heritage item(s) in a well maintained heritage streetscape or landscape setting.
- Heritage item(s) with public access and visibility (note all projects are visible from the public domain).
- Urgent maintenance works to avert management risks e.g. severe deterioration, demolition or demolition by neglect.
- Item(s) that are part of a heritage group or precinct (Heritage Conservation Area).
- Upgrades to fire, service and access to achieve compliance with the Building Code of Australia.
- Ongoing or adaptive reuse of heritage item(s).
- Items that have not received Council funding support in the last five years.

The five projects recommended for funding meet this criteria. Four are allocated \$2,000 and the one with public access (104-106 Mayne Street, Gulgong) is recommended to receive \$3,000.

Taking into account the \$11,000 budget available, Council's Local Heritage Grants Policy, and project costs, Attachment 1 provides the recommended amount to be allocated to each project.

The 2021/22 Operational Plan has an approved budget of \$11,000 for Local Heritage Grants. If Council adopts the recommendations for funding as outlined in this report, the total budget of \$11,000 for this financial year will be allocated.
