## Executive summary

The following report seeks to appoint Council representatives for advisory committees that Council seeks to establish as well as representatives on other external bodies and committees. Some background is provided on the history of Council Section 355 Committees and Advisory Committees as well as setting out the expectations of the Office of Local Government.

## Detailed report

Advisory Committees play an important role in the way that Council communicates with the community across a range of issues. In previous years, Council has established Committees under Section 355 of the Local Government Act. It is proposed to Council that we rationalise our approach to these Committees and focus more on the benefit of these as Advisory Committees.

As per Council Circular 16-24 from the Office of Local Government, Council is encouraged to regularly review the operations of Committees formed under Section 355 of the Local Government Act to ensure they continue to be fit for purpose, and their functions and expenditures align with the goals of the incoming council's Delivery Program.

Historically, previous Councils had established many Committees that would oversee a variety of facilities and undertake functions such as taking bookings for sportsgrounds or community halls. All of these functions are now provided by Council. Some examples of these Committees are the various Sports Councils, the Mudgee Showground Management Committee and the Gulgong Memorial Hall Committee.

Previous Councils also established Committees where Council felt that it needed additional specialist input as it did not necessarily have enough expertise on staff. Examples of these Committees include the Cultural Development Committee, the Heritage Committee and the Environment Committees.

There have also been some issues with the operation of some Section 355 Committees, particularly with the ability to reach a quorum. A number of Committees have been affected by

this from time to time during the last term of Council including the Cultural Development Committee, the Access Committee and the Mudgee Showground Committee.

It is proposed that a number of Committees would be better managed as Advisory Committees that do not need to be fully constituted as Section 355 Committees. Under this plan, meetings could still be managed by staff with input from the public but the need for more formal processes such as quorums, motions and annual general meetings would not be required. Consultation at these meetings can be more focused on strategic objectives and discussion around future plans for Council facilities and operations and services. It would also mean that any member of the community can take part in these advisory committees rather than requiring Council to endorse members who have been nominated. This has worked well with other working parties and consultation processes that have taken place more recently (such as the Flirtation Hill Working Party).

It is recommended that whatever decisions are made around this, all advisory committees consider their Terms of Reference at the next meeting. Advisory committees meet 2-4 times each year.

It is proposed that some Committees are no longer required. Of the Committees that were in operation in the second half of 2021, it is recommended that the Australia Day Selection Committee, the Gulgong Memorial Hall Committee and the Cultural Development Committee are no longer required.

The function of the Australia Day Selection Committee is to consider nominations for the Australia Day Awards. Determining who is on the selection panel for this can be dealt with at any meeting of Council. It does not require a Section 355 Committee to be constituted.

The function of the Gulgong Memorial Hall Committee is to promote the use of the Gulgong Memorial Hall. They also organise a Christmas event. The operation of the hall itself in terms of major maintenance issues as well as bookings and collection of fees are all managed by Council staff. We are now in a different time to when this Committee was established. In previous times, the Committee managed all of the bookings and takings. There is also a lease agreement in place with the Gulgong Men's Shed to provide an additional layer of community oversight to ensure the Hall is looked after.

The original function of the Cultural Development Committee was to assist Council to undertake the works highlighted in the Cultural Plan. Fifteen years ago, Council did not have any specialist cultural staff. With the opening of the Mudgee Arts Precinct, this has changed and specialist, qualified staff are now available to manage cultural matters for Council and the community.

It is important that Council review the operation of these Committees as they do require resources to ensure they are functioning effectively. Council is also spending resources in more significant consultation processes outside of these Committee structures. It is believed that this updated approach will lead to a better overall result for the community.

The link between Councillors and these advisory committees is important and thus Council should continue to select a representative Councillor. Rather than having Section 355 Committees where positions such as Chair or President are elected, it is proposed that the representative Councillor can chair the meetings.

It is noted that it is ultimately up to Council which Committees it would like to see and in what form. It is also open to Councillors to discuss and recommend other advisory committees that may be required or consider previous Committees that were not operational at the end of the

previous term (such as Heritage, Environment, Saleyards, Community Safety and previous Hall Committees such as Botobolar).

In terms of appointing Council representatives to other external bodies and Committees, it is noted that it is a requirement for Council to have a representative on the ones listed in the recommendation For the State Significant Developments, it is required that this representative be a Councillor. There are a couple of external bodies such as Arts OutWest and Public Libraries NSW where the representative does not need to be a Councillor. However, it is up to Council to determine this.

The following is a table of the current Committees and their most recent representative as well as the proposal for the Committee in the future.

In addition to these Committees, it is noted that the Mayor and General Manager are representatives on the Mudgee Health Council by invitation.

It is also noted that a letter of request has come from the Lachlan Valley Transport Committee suggesting involvement from this Council. This is not recommended given the distance between this Council and the area of interest to the Lachlan Valley Transport Committee, which is focused on the area south of the Blayney Shire.

## **Financial implications**

The three Sports Councils are currently provided with a separate budget that allows them to make recommendations to Council for expenditure. It is proposed that these budgets cease operation from the end of June 2022. However, the funds that are currently within those budgets will be held to allow the Sports Councils as advisory committees to make recommendations to Council on the expenditure of those funds.

## Associated Risks

The result of the recommendation is to ensure that all Council operations and finances are managed fully by the organisation with full oversight of the management of Council funds. While these operational frameworks are important, it is also important that appropriate opportunities are provided for ongoing community consultation on a variety of matters and advisory committees are one way in which Council can have this contact with the community and liaise with those groups, organisations and individuals who may be impacted by Council operations, projects and decisions.
