RECOMMENDATION

That Council Approve the event – "Classic Outback Trial", be classified as a Class 2 Event under the 'Guide to Traffic and Transport Management for Special Events Version 3.5' and proceeds with the following conditions:

- a) Events are to be undertaken in accordance with the "Guide to Traffic and Transport Management for Special Events Version 3.5",
- b) A Special Events Transport Management Plan (TMP), is to be prepared in accordance with the "Guide to Traffic and Transport Management for Special Events Version 3.5 and submitted to and approved by Council prior to the event;
- c) Events are to be undertaken in accordance with the requirements of the NSW Police Force with their approval documentation forwarded to Council for notation;
- d) Controlling noise as required by the Protection of the Environment Operations (Noise Control) Regulation 2000;
- e) Reimbursing Council for the cost of damage repairs;
- f) Complying with any of Council's Law Enforcement Officers reasonable directives;
- g) Maintain areas in a clean and tidy condition and no obstructions are to be left on public lands

- h) Any person directing traffic on a public road is required to possess an appropriate traffic controller's certificate;
- Council must be provided with a current copy of a public liability insurance policy in the amount of at least \$20 million. Such a policy is to note that Council, Transport for NSW and NSW Police Force is indemnified against any possible action as the result of the event;
- The event convener is to notify all affected businesses, residents adjacent to the proposed closure and indicating the period during which their accesses will be affected. Such notification is to be in writing. A reminder of the events should be done 3 weeks prior to the event;
- k) Maintain a four-metre wide emergency vehicle lane;
- Advertise the proposed event in local newspapers and Transport for NSW 'Live Traffic', with relevant information at least 2 weeks prior to the date;
- Motify NSW Ambulance and NSW Fire and Rescue of the event;
- n) The organiser is to have a debrief with Council and Police with all traffic control documentation and controls tabled for review; and
- o) Transport for NSW consent required for use of the State and Regional road network.
- p) ensure that all side roads, and /or feeder roads, are closed off to traffic whilst racing.
- q) gates and driveways need to be locked/secured.

Committee Comments

The race organisation needs to do a physical risk assessment due to the condition of bridges and roads.

- Recommendation g) consider extending the "clean and tidy, and no obstructions" requirements to all public lands.
- Recommendation j) consider including a minimum time before the event with a reminder closer to the event.
- Recommendation I) consider also requiring the organiser notify TfNSW 'live traffic' of the event and road closures, unless Council does this
- Cafes Rd Ilford all event participants, organisers and spectators are to be contained clear of the Castlereagh Hwy, i.e. within Cafes Rd, before, during and after the event, no traffic queues, parking or pedestrians related to the event are to be on the Castlereagh Hwy before, during or after the event.
- Razorback Rd route also includes travel on Upper Turon Rd
- TMP-COT 22, Introduction (Agenda p13):
 - o 1st paragraph document is for works in Blayney Shire Council
 - Razorback Rd dot point, should also include that Upper Turon Rd will be closed between Razorback Rd and Red Hill Rd
- Reference to Acts
 - OHS Act needs updating WHS Act 2011
 - Transport Act 1983 which Act now, Road Transport Act 2013 or Transport Administration Act 1988
 - Road Safety (Traffic) Regulation 1988 no longer exists
 - o Transport (Miscellaneous and Compliance) Act 1983 no longer exists
 - AS1742 any particular part or version?
- Emergency services notified (Agenda p29) should Mudgee be included?
- Chapter 7 (Agenda p39) and Chapter 8 (p41) provide a Safety Plan for Special Stages Competitor and Officials. There is no Safety Plan / special consideration for spectators and members of the public, only noted in the risk assessment.

- TGS (Agenda p72-74) the speed zones are not closed out, i.e. there is no release of the 40km/h roadwork speed limit. There is no consideration of existing traffic control devices and what should happen to them.
- Insurance (Agenda p75), Interest Insured The Professional Indemnity cover is only valid if it is 'reported to the insurers during the period of insurance', i.e. 31/12/2020 to 31/12/2021. Is this adequate?

Safety Management Plan needs updating. Page 1 and page 4 are incomplete. Page 5 has no emergency contacts for Mid-Western Regional Council

BUTLER CIRCLE & WURTH DRIVE BOMBIRA - CHILDREN PLAYING IN THE STREETS

SEE ATTACHED WORKS REQUEST

Attached is a works request from a resident in Bulters Circle, Bombira who would like to install a sign at the entrance to the estate saying 'Caution: Drive Slowly. Children at Play'. Her request is for Council to install the sign, or provide permission for her to commission her own sign.

I've spoken to her at length today about the situation currently happening daily in the estate, which is summarised below:

- On a daily basis, up to 40 children (aged from toddler to 12 years) run and ride their bikes on and across the roads of the Bombira estate with little to no regard for traffic.
- They are often heading towards an empty paddock.
- The children are largely unsupervised.
- The children visit her house at 1 Butler Circle often. She is known as the Jelly Bean Queen.
- Mrs Turner believes the children are entitled to play on the road as there is no playground or dog park.
- Mrs Turner does not what to spoil their fun, hence requesting a sign and/or speed humps. She understands that speed humps are not likely to happen.
- Heavy vehicles frequently enter and exit the estate due to ongoing construction projects.
- The number of families with young children in the area will continue to increase. Mrs Turner herself does not have young children.

COMMITTEE COMMENTS

- Little Blue Dinosaur foundation that concentrates on child pedestrian safety.
- this behaviour of the children is usually on school days at 4pm.
- Wurth Drive good to see the overall plan for this area and see what kind of treatment is needed.
- Can we go back to the developer?

ACTION: Transport for NSW will review the speed zones in this area. Council to do an awareness campaigns for children on roads
