#### 2. Submissions & Inquiries

#### 1.1 Draft Kosciuszko National Park Wild Horse Heritage Management Plan

On 1 November 2021 the Murray Darling Association provided a submission to the NSW Department of Planning, Industry and Environment consultation on a draft Kosciuszko National Park Wild Horse Heritage Management Plan.

The MDA put forth recommendations on unchecked damage to the environment, feral horse reduction and confinement, introduction of a control plan and investment in the ecosystem, as well as compliance and operational and strategic alignment.

The MDA submission to the Draft Kosciuszko National Park Wild Horse Heritage Management Plan is available for viewing on the <u>MDA website</u>.

#### 1.2 MDA Pre-Budget Submission

In September 2021 the Murray Darling Association provided a pre-budget submission to the Australian Government Treasury.

Through the submission, the MDA seeks the necessary funds to support, and collaborate with Basin governments in the implementation of the Murray-Darling Basin Plan, and the development of agreed water sharing arrangements beyond 2024.
