# **Executive summary**

This report considers requests for financial assistance under Council's Community Grants Program Policy.

Provision is made in Council's Community Grants Program Policy to provide financial assistance to not-for-profit community-based organisations, groups and individuals that offer a significant contribution to community outcomes and goals as provided in the Towards 2030 Community Plan.

All applications were first reviewed for eligibility and then assessed by a panel of three staff against the following criteria relative to the amount of funding requested:

• Degree of benefit to the community aligned with the community plan.

- Level of consultation and collaboration with other local groups.
- Organisational capacity to deliver the program or project.

Even though an application meets the criteria it may be judged that there is not a significant enough benefit to the community in order to fund or fully fund the request. A summary of each application is shown below, together with panel recommendations.

# Detailed report

# **Mudgee Show Society**

Mudgee Show Society requests \$5,000 for the annual Mudgee Show and Rodeo. This is a Family event that brings competition, fun and exhibits to Mudgee. Competitors and Spectators travel from a vast region to attend and compete and display their works. Family fun day out with entertainment and competitions.

## **Gulgong Golf Club**

Gulgong Golf Club requests \$2,500 for Tree Planting in the golf course. Planting tube stock trees to restore the course for the benefit of the community and environment as lots of trees have been lost due to drought and age.

The Panel scored the application as 3 and there does not appear to be significant benefits linked with the objectives of Councils Community Plan so no amount was recommended.

## **Australian Rural Education Centre Co-op Ltd**

Australian Rural Education Centre Co-op Ltd requests \$14,050 for Reimbursement of Council rates and water for 2020-2021 financial year. AREC is a local, non for profit registered charity. The Mudgee small farm field days are the single largest annual event in the Mid-Western region, which brings millions of dollars into the local economy each year. Numerous community organisations and local businesses benefit significantly from the event. The 2020 and 2021 Field days had to be cancelled due to COVID-19, which has resulted in the loss of almost two entire yearly income and caused significant financial distress. It is in the entire Mid-Western region community's best interest that the Field days remain financially viable so they continue into the future.

## **RECOMMENDATION:**

\$5,000

The Panel scored the application as 10 and there appear to be significant benefits linked with the objectives of Councils Community Plan but has a cap of \$5,000 so cap amount was recommended. They currently have a dispute going on with council regarding water rates and have not paid it since 2021 FY.

## **CWA Mudgee**

CWA Mudgee requests \$10,000 to publish a book on the 100 years history of CWA Mudgee. Our 100 year anniversary will be in May 2022 and it is hoped to have a book to launch at that time. We have a lot of history and volunteer to research and draft the book. This would be of significant cultural value to the community and preservation of the local history for generations to come.

## Anglican Church of Rylstone and Kandos

Anglican Church of Rylstone and Kandos requests \$1,500 for 100 year anniversary of St Laurence Kandos. A church celebration service for 100 years since St Laurence began church services. St Laurence has limited capacity and we anticipate a gathering of people for this occasion beyond its size. We are requesting that Jaques Street be closed for the time. However, in the event of wet weather, we would like to use the Kandos Community Centre

# Riding for the Disabled Association NSW Mudgee Centre

Riding for the Disabled Association NSW Mudgee Centre requests \$40,000 for Shed walls/lined and fit out completion. Line the walls of the Riding for the Disabled Association (RDA) shed with either Gyprock, timber sheeting or yellow tongue groove boards and then have a kitchenette fitted complete with a refrigerator and free standing stove. We would like the shed completed to celebrate RDA 10yrs in Mudgee and to offer a place for our riders/carers and volunteers to still participate in the RDA program in inclement weather.

## **RECOMMENDATION:**

The Panel scored the application as 9 and there appear to be significant benefits linked with the objectives of Councils Community Plan but has a cap of \$ 25,000 or 50% of the total project cost whichever is the lower, so the 50% of 40,000 was recommended.

## **Gulgong Show Society**

Gulgong Show Society requests \$3,000 for Gulgong rural agriculture show. Gulgong rural agriculture show brings fun competitions and events for the local community and the region as a whole. It also brings many visitors to the town and support local businesses with our purchasing and hire of equipment.

# Rylstone, Ilford-Running stream & Kandos CWA

Rylstone, Ilford-Running stream & Kandos CWA requests \$2,500 for International Women's Day Luncheon. 3 small town CWAs from Mid-Western Regional Council areas will host an International Women's Day Luncheon to celebrate "Breaking the Bias". The guest speaker is the renowned Jane Caro AM. Our local Wiradjuri people will open the day, and mental health professionals will also give a talk about dealing with COVID-19, isolation, drought and floods.

The Panel scored the application as 7 and there appear to be medium benefits linked with the objectives of Councils Community Plan so 75% of the requested amount was recommended.

## Rotary Club of Mudgee Inc. and Rotary Club of Mudgee Sunrise Inc.

The Rotary Club of Mudgee Inc. and Rotary Club of Mudgee Sunrise Inc.'s requests \$ 1,634.18 fee for the Mudgee Showground hire and bin hire be waived.

The Rotary Club of Mudgee Inc. and Rotary Club of Mudgee Sunrise Inc.'s application was previously assessed at the 21 July 2021 council meeting and they originally requested \$7,000 payment for Mudgee Showground Carols for the annual celebration of Christmas for Mudgee community. At this meeting it was resolved to provide financial assistance of \$5,000. This was the amount recommended as this was the Community Grant Category Cap.

In previous years this fee has been waived so they are requesting for it be waiver again for the recent event held 11 December 2021.

# Financial implications

Funding of \$110,000 is provided in the Operational Plan for financial assistance plus an additional budget of \$106,196 approved, which brings to the total of \$ 216,196. Out of which \$144,253 has already been allocated, leaving a balance of \$71,943. Based on the scoring system above, the recommendation of staff is to provide \$40,625 in financial assistance. Should Council approve the recommendations in the report, a balance of \$31,318 will remain.
