#### **RECOMMENDATION**

- 3. adopt the Mid-Western Regional Cultural Plan 2023-2033 if no submissions are received during the exhibition period.

## **Executive summary**

The last Mid-Western Regional Cultural Plan ('Cultural Plan' or 'Plan') adopted by Council dates back to 2005. Since then, there have been a number of significant regional developments in the arts and cultural environment across the region necessitating a review of this document, including the opening of the Mudgee Arts Precinct.

# **Detailed report**

In late 2022, Council engaged the consultancy firm, *Projectura* to develop a new Cultural Plan for the region. The Plan assesses the general health of the region's cultural sector and specifically identifies Council's future roles within the sector. The Plan also identifies service gaps and leverage opportunities.

Engagement for the Plan in the first half of 2023 was extensive and included an online survey, popup stalls region-wide, and a series of interviews and workshops. Overall, 250 individuals were consulted in respect of their opinions and hopes for arts and culture in the Mid-Western Region going forward.

The Plan identifies our region's social fabric and local skills and enterprise as strengths but notes challenges in financial sustainability in the arts and also the lack of creative venues and spaces. People are involved in arts and culture through festivals and community events and programs and through visits to the Mudgee Arts Precinct, Council libraries and local history museums. Participation is for entertainment, to support local artisans and, more generally, for happiness and wellbeing. Barriers to participation, however, include a lack of information about planned activities (or their scarcity), as well as distance and cost to attend same.

The Plan documents the goals and actions prioritised by the community during engagement activities and delegates Council's role for each action broken down into four main themes:

- Celebrating and reflecting on our region's heritage, history, memory and stories;
- Revitalising and expanding our cultural services;
- · Supporting our creative community; and
- Providing activities for everyone, everywhere.

A copy of the final Cultural Plan intended for exhibition and subsequent adoption is attached to this report.
