### DRAWING NOTE:

AS PREVIOUSLY FLAGGED, NDY REQUIRE ADDITIONAL HYDRAULIC INFORMATION IN ORDER TO PROVIDE THE DESIGN. IN PARTICULAR, NDY REQUIRES THE PRESSURE AND FLOW RATE INFORMATION (PFI) FOR THE SITE. THIS INFORMATION HAS MAJOR IMPLICATIONS FOR THE HIGH-LEVEL DESIGN OF THE HYDRANT SYSTEM, WHICH HAS FURTHER SIGNIFICANT FLOW-ON EFFECTS ON COST.

IN PARTICULAR, THE PFI IS REQUIRED TO DETERMINE IF THE EXISTING STREET HYDRANTS MEET THE REQUIREMENTS OF AS 2419.1-2021. IF THEY DO NOT MEET THE REQUIRED PRESSURE AND FLOW RATE, FIRE PUMPS AND TANKS ARE REQUIRED TO BE PROVIDED, WHICH IN TURN REQUIRES THE PROVISION OF A FIRE BRIGADE BOOSTER VALVE ASSEMBLY (FBBVA) AND EXTERNAL HYDRANTS.

AS THE PFI INFORMATION WAS NOT PROVIDED TO NDY, IT IS UNCLEAR IF FIRE PUMPS AND TANKS ARE REQUIRED. AS SUCH, THIS DOCUMENT SHOWS TWO SCENARIOS:

- SCENARIO (A): PUMPS AND TANKS ARE REQUIRED, FBBVA IS TO BE PROVIDED, NEW EXTERNAL HYDRANTS ARE TO BE PROVIDED THROUGHOUT THE SITE. - SCENARIO (B): NO PUMPS AND TANKS, NO FBBVA (PROVIDED ALL REQUIREMENTS OF CLAUSE 7.2 OF AS2419.1-2021 ARE ALSO MET), HYDRANT COVERAGE IS PROVIDED WITH EXISTING STREET HYDRANTS FOR THE MOST PART.

NDY IS REQUIRED TO DESIGN TO SCENARIO (A) AS THE WORST CASE SCENARIO WITHOUT THE PFI. THIS IS <u>SIGNIFICANTLY</u> MORE COSTLY AND MORE COMPLEX THAN SCENARIO (B). IT WOULD ALSO REQUIRE SIGNIFICANT MODIFICATION TO THE SITE LAYOUT TO ACCOMMODATE THE WATER STORAGE TANKS AND PUMP HOUSE (APPROX. 11m x 11m TANKS AND 6m x 5m PUMP HOUSE) AS SUCH, NDY'S RECOMMENDATION IS FOR CAG TO ENGAGE A CONTRACTOR TO TEST THE SITE AND PROVIDE THE REQUESTED PFI.










## SCENARIO (A) FIRE LAYOUT (PAGE 3/3) - FBBVA, PUMPS AND TANKS REQUIRED.
