## Criteria and Eligibility

The 2024 Mid-Western Regional Council Senior Citizens Awards recognise outstanding contributions and achievements to the community by senior citizens of Mid-Western Regional Local Government Area.

One award will be presented to an individual or an organisation each of Mudgee, Gulgong, Rylstone and Kandos at award presentations in each centre. Senior Citizens from each of these centres and the areas surrounding these centres will be eligible to be entered for the award in their respective community.

Any individual nominated must be over 55 years of age and must be a resident of Mid-Western Regional Council Local Government Area.

Any organisation nominated must have a membership of people predominantly over the age of 55 years and must be based in the Mid-Western Regional Council Local Government Area.

Individuals or organisations who have previously received Seniors Awards are ineligible to receive further awards.

#### CRITERIA FOR JUDGING WILL INCLUDE THE FOLLOWING

- Degree of initiative shown by the nominated person/organisation have they established a new service or facility or supported existing initiatives?
- Whether the work of the nominated person/organisation has impacted on one or many sectors of the community
- Whether the community work of the nominated person/organisation has been done by themselves or as part of a wider group with more shared responsibilities
- Have the achievements of the nominated person/organisation made an ongoing impact on society

People nominating individuals or groups are urged to address these criteria in their 250 word supporting material to assist judges in assessing the contributions of the senior citizens nominated.
